

SNOW RELIEF TEAM PROGRAM

CONSENT AND RELEASE

Property Owner, _____,

hereby gives the expressed consent for the Snow Relief Team to provide snow removal, services on the sidewalk and **if time permits, some limited services to the driveway of the property listed below**. Number of applicants applying to the program, will be a determining factor of driveway services. Snow Relief Team **will not** remove ice from driveway or sidewalk areas. If the property owner requests a snow/ice melt chemical be applied to the shoveled areas, the chemical must be provided by the property owner. Property owner specifically acknowledges that there may be melting and freezing after the Snow Relief Team has cleared the sidewalk and driveway.

Property Owner for the sole consideration of receiving said services, does, for itself, its heirs, executors, administrators, successors, and assigns, hereby release, acquit, and forever discharge City, Snow Relief Team and any of its officers, employees, elected officials or volunteers from any and all causes, actions, causes of action, demands, rights, damages, costs, loss of service, expenses, compensation, court costs, and attorney fees whatsoever, including those which in any way grow out of any and all known and unknown, foreseen and unforeseen damages or injuries and the consequences thereof, resulting in or in any way directly or indirectly connected with the provision of snow removal services by the Snow Relief Team.

3. Property Owner hereby covenants and undertakes to forever refrain and desist from prosecuting or asserting against City, Snow Relief Team and any of its officers, employees, elected officials or volunteers any claim, demand, action, or suit of whatever

kind or nature, either directly or indirectly, for claims at law or equity alleged to have resulted from the assistance provided by the Snow Relief Team, and Property Owner hereby expressly agrees to indemnify and hold harmless City, the Snow Relief Team and any of its officers, employees, elected officials or volunteers from any damages, costs, or expenses, including attorneys' fees and other expenses of litigation incurred by or on behalf of City, the Snow Relief Team and any of its officers, employees, elected officials or volunteers.

4. The owner of such private property requesting snow removal services acknowledges and agrees that such **snow removal is provided for on an availability basis only and subject to more than one (1) inch of snow. Services will not begin until anticipated snowfall has stopped.**

5. The City may decline to provide any services under this Agreement if the conditions of such facility requested to be serviced, call into question the safety of City personnel and/or equipment.
