Discussed transition with Assessments and delayed new referrals with providers until January when ae can work out a process. Kim Cullis will be at Board Meeting to bring up concerns. Medicare open enrollment appointments are almost full, and we will notify KDADS once we are full with those appointments. BNSF gave \$10,000 grant for SCHICK & we have received some other donations and so we were able to open up some evening and weekend appointments to serve more people. We will be starting a waiting list for CHAMPSS program as of 10/10 after the October Lawrence Orientation. The process for getting individuals off the waiting list will make sure we are hitting the targeted OAA population. We are looking at the possibility of 2 additional meal sites. We reached out to Jessica at Midland, and she is exploring those options & would depend upon funding as well.
 - b. OAA Programs Report- No updated Report
 - c. Strategic Plan- We are not exploring the walk-in sites in Jefferson or Douglas Counties. We did hit the target revenue goal between core funding and grants. We have been doing some Facebook posts and trying to get out to the public the need for more Advisory Council and Board members. The Digital Media Coordinator is working on the website and has sent out for staff to look at and add their input with things they think could be changed or better.
