From the Executive Director's Desk

Budgets. We all deal with budgets, especially household budgets. Every month, we try to work within our means. But sometimes, the "bottom line" tells us our needs exceed our means. So, we "tighten our belts" to stretch income as far as we can.

Now imagine getting to the end of the month and you find you're \$700 million short. In Kansas, our government leaders are facing this very challenge.

Governor Kathleen Sebelius has released her budget for the state of Kansas for the coming 2004 fiscal year, and unfortunately, the amount allocated for aging services is \$800,000 less than that of the current 2003 fiscal year. In other words, local Area Agencies on Aging will be expected to do much more with much less.

Gov. Sebelius' budget is the first draft of many, and our legislators are working to come up with solutions to the shortfall. Hard decisions will need to be made.

At Jayhawk Area Agency on Aging, we will continue to work hard to stretch our resources as far as possible, making the most fiscally responsible decisions we can to help seniors live independent and dignified lives. But we cannot do it without your help.

As an advocate for older Kansans, it is crucial that you contact your elected officials and let them know how beneficial and cost-effective in-home services are to our fellow Kansans. (For helpful statistics, see the chart inside this edition of "Amazing Aging!") The bottom

line is that the funding of in-home services for seniors is both fiscally responsible as well as beneficial to the well-being of our aging population.

Helpful Facts on In-Home Services

We have given you much food for thought regarding the current budget crisis facing aging services, and you are ready to contact your legislator. But are you unsure of what to say? We have that covered! We have included a sample letter you are welcome to use to contact your legislator, and there are some valuable statistics included. Keep them handy when calling your legislator. Thank you for advocating for seniors, helping them live independent and dignified lives!



SAMPLE LETTER

Dear Senator/Representative,

As one of your constituents, I wanted to let you know my views on the state programs that provide in-home services for seniors.

Senior Care Act (SCA) and Home Community Based Services (HCBS) are two programs that are very important to the seniors of our community, yet both of these programs have waiting lists for people who need the help.

The two programs provide the most basic needs for our seniors by addressing routine housekeeping chores and assisting with personal care such as bathing and dressing. These services help seniors stay in their home and out of nursing homes.

Annual costs of care by program (per person):

- Senior Care Act \$1,200 (with state-wide waiting list of 640 people)
- Home and Community-Based Services \$12,000 (with a state-wide waiting list of 1,092 people)
- Nursing Home \$28,800 (cannot be a waiting list the state MUST pay for this level of care)

Funding for these in-home programs are not only the right thing to do for our seniors, it is also the economical thing to do.

Please work to address the funding needs of these two programs. It will help to reduce the entitlement expenses of nursing home care.
